- To initiate the development of the underprivileged youth for providing skill development training for making them job ready in the sectors of IT-BPO, MFI, Warehouse and Sales.
- Organizing Activities in Berhampore Girls College for sourcing right candidates for the Job-linked programme.

# II. Eligibility Criteria for getting certified to grab a job:

Minimum Class XII Passed out. Age Limit: 18 Years to 28 Years and Minimum 80% of the student's attendance in the entire duration of Three(03)Months Training program and have to secure 70% marks in the conducted Examination.

### III. Deliverables of Berhampore Girls College:-

- 1. Cooperation to conduct programs on mutually decided date, time and place.
- 2. Access to the students at BG College to motivate and interact with them relating to job opportunities and relevant trainings subject to the convenience of the college.
- 3. Provide available infrastructure free of cost to conduct interactive sessions with the students at BG Ccollege.

#### IV. Financial arrangements:-

- a. No financial commitment is required / involved with BG Coollege to execute the terms and conditions of the MoU.
- b. However, the Bandhan Konnagar shall charge maximum of Rs. 4000/\*- (non-refundable) as course fees (Onetime Payment) for training program from the students.
- \* Subject to change after consultation with BG College.

#### V. Terms and conditions:-

It is mutually understood and agreed by and between BG College and Bandhan Konnagar, that the MoU will remain effective for 3 (Three) years. The mutual discussion between the two Institutes viz. MoU may be extended or revised after every 3 (Three) years on BG College, and Bandhan Konnagar. Awareness and Seminars/ Mobilization would be conducted as and when required, either at BG College, Murshidabad Bandhan Konnagar both places, on the basis of mutual consent.

- This MoU shall be governed and construed according to the laws of the country for each participating party. Any dispute will jointly be resolved involving the Principal of Berhampore Girls College and the Bandhan Konnagar, Shrachi EK Tower, 7th Floor, 12 Street numbers 692, Plot No: IID/30, Action area IID, New Town, West Bengal 700161, in a spirit of independence, mutual respect, and shared responsibility.
- The MoU may be terminated by either party after giving a notice of six months (180 days) provided that this clause will be operative only if either party violates the terms of MoU or if the parties feel that no useful purpose would be served by further continuing it either due to change in circumstances or change in constituting parties.
